Legal protection for patients

- » **Legis^{sana+}** helps you defend your interests when you have sustained damage in connection with a medical treatment or a breach of your health privacy rights.

Medical errors can have serious consequences, and the legal steps required to protect your rights are often long and very costly.

With **Legis^{sana+}**, you will be assisted by competent lawyers or legal experts to defend your interests in the event of disputes with the medical profession (doctors, dentists, surgeons, physiotherapists, etc.) and with hospitals and clinics. You are covered in particular in the following cases:

- In the event of an error in diagnosis or medical treatment (including the most common cosmetic procedures)
- In the event of a breach of data protection rights by the medical profession
- In the event of a defect in a medical product or device (e.g. a faulty hip prosthesis)

Dextra Protection juridique SA provides unlimited cover for legal defence.

If the case needs to be referred to an independent lawyer (due to the complexity of the case or legal proceedings before a court), insurance cover is limited to CHF 500,000 per case.

If the event giving rise to the dispute took place outside Switzerland (or if a court abroad has jurisdiction), insurance cover is limited to CHF 50,000 per case.
