# Groupe Mutuel has pledged CHF 2 million to support Swiss citizens, SMEs and the medical profession during the Covid-19 crisis

Martigny, 26 March. As a socially responsible and committed company, Groupe Mutuel, through its Foundation, has decided to actively support people in need by donating CHF 1 million to the Chaîne du Bonheur. Groupe Mutuel Foundation is also joining forces with Vaudoise Assurance and QoQa to support small and medium-sized businesses (SMEs) by taking part in an innovative project and donating an additional CHF 1 million. Finally, Groupe Mutuel will also support the medical professional by making specialised staff available to the Swiss health system free of charge.

## Supporting citizens in need

The public health and financial crisis caused by the coronavirus is currently putting many people in a difficult situation. Alongside the measures taken by the Swiss Confederation and cantons, the Chaîne du Bonheur is taking action to help these people. It provides support to individuals and families severely affected by the financial, health and social consequences of the crisis, by offering targeted and immediate assistance. Groupe Mutuel Foundation commends this initiative and is making its own contribution with a donation of CHF 1 million. #### Groupe Mutuel, Vaudoise Assurance and Qoga are joining forces to help SMEs

The two largest insurers in French-speaking Switzerland are joining forces with QoQa to support those small retailers and producers in Switzerland that are now facing financial hardship. From Thursday onwards and via a new platform, QoQa will provide the opportunity for citizens to support the economy by purchasing vouchers that will be redeemable at local retailers. Through this commitment, Groupe Mutuel Foundation is taking concrete action to support local businesses. Thanks to this initiative, in partnership with QoQa, it will be possible to provide tangible help to retailers", added Thomas Boyer, CEO of Groupe Mutuel.

## Groupe Mutuel is committed to supporting the health system

On a voluntary basis, Groupe Mutuel will allow its specialised staff (nurse consultants, pharmacy assistants and pharmacy advisers) to become involved with health institutions. In this way, as a stakeholder in the healthcare system, Groupe Mutuel intends to show solidarity with the healthcare providers who work daily to fight the coronavirus and save lives.

In addition to these initiatives for the general population, Groupe Mutuel has taken several concrete and action-oriented measures to help its customers, such as suspending commercial rents and debt recovery procedures.

Groupe Mutuel has also reorganised its activities to ensure the highest level of service to its insured persons while safeguarding the health of its employees. In this regard, over 90% of its teams are now providing services to customers directly from their homes.
