## Supplemental health insurance

Avoid significant medical and pharmaceutical costs by choosing coverage that meets your expectations.



Supplemental health insurance covers expenses which are not reimbursed by compulsory health insurance and is an ideal addition to legal benefits that are often limited:

- drugs not recognised by LAMal/ KVG
- o alternative medicine
- vaccinations
- transport costs
- o home help costs

- o glasses and contact lenses
- o contribution to dental costs
- independent psychologists and non-doctor psychologists
- thermal and convalescence cures







Benefits are reimbursed up to the overall amount of coverage decided upon when taking out insurance. You may choose between four levels:

- O level 1: CHF 8,000 per calendar year
- O level 2: CHF 10,000 per calendar year
- o level 3: CHF 15,000 per calendar year
- o level 4: CHF 20,000 per calendar year
